ARTICLES OF INCORPORATION

OF DEERWOOD LAKES ASSOCIATION, INC.

We, the undersigned, natural persons of the age of eighteen (18) years or more, at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Nonprofit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE

NAME

The name of the corporation is DEERWOOD LAKES ASSOCIATION, INC., hereinafter sometimes called "the corporation" or "the association".

ARTICLE TWO

NONPROFIT

The corporation is a nonprofit corporation.

ARTICLE THREE

DURATION

The period of its duration is perpetual.

ARTICLE FOUR

PURPOSES AND POWERS

The purpose or purposes for which the corporation is organized are to promote the recreation, health, safety and welfare of the owners of property in the Deerwood Lakes, Deerwood North and Deerwood East Subdivisions; to improve and maintain the common area, including but not limited to, maintaining and operating the pool area, golf course, tennis courts, and the clubhouse, pavilion, and green area within those certain tracts of land comprising said subdivisions described on Exhibit "A" attached hereto and incorporated herein for all purposes, and any additions thereto as may hereafter be brought within the jurisdiction of this association, for this purpose to:

a. Exercise all of the powers and privileges and perform all of the duties and obligations of the association as set forth in the property restrictions hereinafter called "the restrictions" applicable to the property and recorded in the Official Public Records of Real Property of Waller County, Texas, and as the same may be amended from time to time, said restrictions being incorporated herein as if set forth at length;

- b. Fix, levy, collect and enforce payment by any lawful means, all charges or assessments pursuant to the terms of the restrictions; pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the association, including all licenses, taxes, or governmental charges levied or imposed against the property by the association;
- c. Acquire (by gift, purchase or otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, dedicate for public use or otherwise dispose of real or personal property in connection with the affairs of the association.
- d. Borrow money, and with the assent of 2/3rds of the members, mortgage, pledge, deed in trust or hypothecate any or all of its real or personal property as security for money borrowed or debts incurred;
- e. Dedicate, sell or transfer all or any part of the common area to any public agency, authority or utility for such purposes and subject to such conditions as may be agreed to by the members. No such dedication or transfer shall be effective unless an instrument has been signed by 2/3rds of the members, agreeing to such dedication, sale or transfer;
- f. Participate in mergers and consolidations with other nonprofit corporations organized for the same purposes or annex additional property in common area, provided that any such merger consolidation or annexation shall have the assent of 2/3rds of the members;
- g. Have and exercise any and all powers, rights and privileges which a corporation organized under the Texas Nonprofit Corporation Act by law may now or hereafter have or exercise.

ARTICLE FIVE

MEMBERSHIP

Every record owner, whether one or more persons or entities, of fee simple title or equitable title under an Agreement for Deed, in any lot which is subject by restrictions of record to assessment, shall be a member of the association. The foregoing is not intended to include persons or entities who hold an interest merely as security for the performance of an obligation. Membership shall be appurtenant to and may not be separated from ownership of any lot which is subject to assessment by the association.

ARTICLE SIX

VOTING RIGHTS

The association shall have two (2) classes of memberships.

Class A. Class A members shall be all owners described in Article Five above with the exception of General Mortgage Corporation. Class A members shall be entitled to one vote for each lot in which they hold the interest required for membership. When more than one person holds such interest in any lot, all such persons shall be members, but shall be limited to a total vote of one. The vote for such lot shall be excercised as they among themselves determine, but in no event shall more than one vote be cast with respect to any lot.

Class B. The Class B member shall be General Mortgage Corporation. The Class B member shall be entitled to three (3) votes for each lot in which it holds the interest required for membership; provided, however, that the Class B membership shall cease and be converted to Class A membership on the happening of either of the following events, whichever occurs earlier:

- (a) When the total votes outstanding in the Class A membership equal the total votes oustanding in the Class B membership, or
- (b) January 1, 1987.

The Class A and B members shall have no rights as such to vote as a class, except as required by the Texas Nonprofit Corporation Act, and both classes shall vote together upon all matters as one group.

Only those members who are current in the payment of maintenance assessments as required under the terms of the restrictions shall be entitled to vote.

ARTICLE SEVEN

QUORUM

Members of the DEERWOOD LAKES ASSOCIATION, INC. holding one-tenth (1/10th) of the votes entitled to be cast, represented in person or by proxy, shall constitute a quorum at any meeting of the members. The vote of the majority of votes entitled to be cast by the members present or represented by proxy at a meeting at which a quorum is present, shall be the act of the members.

ARTICLE EIGHT

BOARD OF DIRECTORS

The affairs of this association shall be managed by a board of three (3) directors, who need not be members of the association. The number of directors may be changed by amendment of the by-laws of the association. Notwithstanding the foregoing, until the election of directors at the first annual meeting of the members, the three (3) initial board of directors shall so serve.

ARTICLE NINE

DISSOLUTION

The association may be dissolved with the assent given in writing and signed by not less than 2/3rds of the members. Upon dissolution of the association, other than incident to a merger or consolidation, the assets of the association shall be dedicated to an appropriate public agency to be used for purposes similar to those for which this association was created. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed and assigned to any nonprofit corporation, association, trust or other organization to be devoted to such similar purposes.

ARTICLE NINE-A

AMENDMENTS

Amendments of these articles shall require the assent of two-thirds (2/3rds) of the votes of the entire members.

ARTICLE TEN

REGISTERED AGENT
